SB 1022 Application for State Construction Financing Funds Background

Hall of Justice

- Top capital plan priority since 2006
- Constructed in 1958, it is second to SF General Hospital in total regular occupancy with over 3,000 individuals using the facility on a daily basis
- Expected structural and non-structural damage from a large earthquake would be very severe and pose appreciable life hazards, likely require vacation of the building
- Maximum security Jails #3 and Jail #4 containing 905 beds are on the top two floors
- Could result in tens of million of dollars for temporary relocation of inmates until repairs are complete or a new facility is constructed



SB 1022 Application for State Construction Financing Funds Background

Justice Facility Improvement Program

- 2007 Comprehensive assessment and Real Estate analysis identified the need to double the size of the current building to meet current modern standards and regulations
- □ Total cost of approximately \$1.5 billion program covering 15 years
- 2008 Capital Plan developed financing strategy including the relocation of various units through the Earthquake Safety and Emergency Response bond program and use of General Fund debt (C.O.Ps) within established fiscal constraints
- Subsequent Capital Plans and pre-development studies have moved the implementation strategy forward
- State Realignment and low jail population led to independent forecasts of future prison population reflected in current capital plan



SB 1022 Application for State Construction Financing Funds Jail Replacement Project Overview

Controller Assessment

- Forecast of future jail population shows need for a 30% smaller (from 905 to 640 beds) and a 10% reduction to overall system capacity
- Additional study currently underway could further reduce the number of beds
- Indirect Supervision or linear jail design presents safety liabilities for inmates and staff
- HOJ jails provide very little program space

Current Project

- \$290 million total project cost including purchase of property east of the Hall of Justice
- Construction starting in 2017 and completing in 2019
- New facility will be a modern direct supervision jail similar to County Jail #5 with increased program space and visibility




SB 1022 Application for State Construction Financing Funds Jail Replacement Project Overview

Senate Bill 1022 Grant Opportunity

- Competitive grant program exclusively for the construction of Sheriff run criminal justice facilities with improved rehabilitation program space
- San Francisco is eligible to receive up to \$80 million and has already met local match requirements
- Application does not commit the City to a particular project and does not change environmental (CEQA), Capital Planning Committee, and Board of Supervisors approval process
- Decision to accept funds would require purchase of replacement site within 90 days
- State funds would accelerate remaining high-priority HOJ projects identified in the Capital Plan
- ☐ Grant application due to the State on October 24, 2013

Hall of Justice Replacement Jail Capital Plan



Justice Facilities Improvement Program (JFIP): A comprehensive planning effort from 2006 to 2009 that resulted in a \$1.5 billion capital program to replace the Hall of Justice (HOJ).

- Earthquake Safety and Emergency Response Bond ESER 1 \$412.3M GO Bond approved by voters June, 2010; JFIP projects:
 - SFPD Headquarters and Southern District Station \$243M
- Earthquake Safety and Emergency Response Bond ESER 2 \$400M GO Bond planned for June, 2014; JFIP projects:
 - SFPD Traffic Company and Forensic Services Division \$165M
 - Office of Chief Medical Examiner \$65M
- Replacement Jail \$290M GF Debt
- Relocate District Attorney and Adult Probation \$225M GF Debt
- Relocate SFPD Investigations Unit \$133M GF Debt*
- Demolish West Wing of HOJ to allow State to build a new Courts Building at 7th Street and Bryant Street \$38M GF Debt*

Hall of Justice Replacement Jail SB 1022 Grant Application

SB1022 Construction Financing Program

- Competitive grant program to construct criminal justice facilities with improved rehabilitation program spaces
- Potential maximum grant to San Francisco: \$80M
- Total available statewide: \$500M

Benefits to San Francisco

Award of SB1022 funds will allow reallocation of General Fund Debt Program for other high priority needs in the Ten-Year Capital Plan.

Key Dates

- Support from Capital Planning Program received, September 9, 2013
- Resolution to support the application to the Board of Supervisors on October 1, 2013
- Resolution to support at Budget and Finance Committee, October 9, 2013
- Resolution to support at Board of Supervisors on October 22, 2013
- Application due to the State by October 24, 2013
- Conditional Grant Announcements January, 2014



Hall of Justice Replacement Jail Needs Assessment

Current Situation

- 905 jail beds on Hall of Justice 6th and 7th floors (rated and unrated)
- Linear jail design presents safety liabilities for inmates and staff
- HOJ jails provide very little program space

Forecast of Jail Population

- Based on work by 2 external consultants and reviewed and affirmed by the Controller's Office need estimated between 481 to 688 beds
- 4 main elements
 - Baseline forecast using statistical methods
 - Estimate of realignment impacts
 - Classification factor: 5-9%
 - Peaking factor: 5-14%

Next Steps

The Controller's Office will conduct an updated study on the overall system "need" in the winter of 2013-14.

 - Title information
 - Preliminary data regarding valuations
 - Preliminary data regarding environmental condition of parcels
- Pre-Acquisition Process Underway
 - Appraisals, Brokerage Contracts, Final Title Reviews

Timeline

- Confirmation of Values, Commence Negotiations October 2013
- Introduction of Authorizing Resolution for Acquisitions **November 2013**
- Completion of Purchases No Later Than 90 days After Grant Award
- Relocations from Site Completed After CEQA Clearance Secured





Jail Replacement Project

Scope: Full Replacement - 903 Beds

- Replace existing HOJ jails with a facility conforming to state standards.
- Minor jail system integration projects, including medical & food services improvements, to adapt system to new jail.

Project Budget

- **\$435M**
- Special Equipment, FFE budget TBD

Funding

- General Fund: Planning, preliminary design, and site options
 - Previous Approp. = \$6.3M
 - FY12-13 Request = \$3.7M
- COPs: Site purchase, design, construction \$425M

Construction Start Summer 2016 – Completion Spring 2019
