Construction Notice: Segment 4

Dear Polk Street Community Member,

San Francisco Public Works has contracted with **M Squared Construction Inc.** to begin utility repair and infrastructure improvements in your neighborhood as part of the Polk Streetscape Project (Contract No. 2126J).

Construction for Segment 4 (**Polk Street, from Beach to Vallejo streets**) will begin the week of **November 9, 2016**.

Crews will begin with installation of sewer manholes at Bay Street, followed by sewer and water main work, concrete flatwork, electrical work and final grinding and paving.

Additional planned work for Segment 4 include: installation of ADA curb ramps, sidewalk bulb-outs, street light upgrades, bicycle lane improvements, and landscaping work.

Please note that actual work on your block may not begin for several weeks or months after this date depending on the type of work planned for your block. Construction activity for Segment 4 is anticipated to continue through **October 2017**.

Anticipated construction schedule for Segment 4:

AWSS (Auxiliary Water Supply System) work: 11/2016

Sewer work: 11/2016 - 04/2017

- Bay to Greenwich
- Filbert to Union

Water work: 12/2016 - 04/2017

- North Point to Bay
- North Point to Chestnut
- Chestnut from Van Ness to Polk
- Lombard to Filbert

Concrete Flatwork: 04/2017 - 09/2017

Electrical work: 04/2017 - 05/2017

Final Grind & Pave: 09/2017 - 10/2017

Impacts and Restrictions

Street parking may be unavailable during different phases of construction. Access to private or commercial buildings and pedestrian pathways will be maintained at all times, however delays may be possible.

"No Parking/Tow Away" signs will be posted 72 hours in advance of work starting with project work hours and parking restrictions. Please observe parking and traffic signage and allow extra travel time in case of traffic delays during construction. Vehicles parked in the construction zone during posted work hours will be towed at the vehicle owner's expense.

Work Hours

Monday - Friday: 8 AM – 4 PM

Weekend/evening work may be possible, but has not been scheduled at this time. The San Francisco Water Department usually performs water connection work at night, when demand for water service is reduced. You will be notified of any scheduled overnight tie-in work by SFWD.
