Construction Update: Third Street Bridge - Phase II

Dear Third Street Bridge Neighbor,

The **Third Street Bridge Rehabilitation Project** will soon begin **Phase II** of rehabilitation work planned for Lefty O'Doul Bridge on 3rd Street between Berry Street and Terry A Francois Boulevard.

Phase I was completed between December 2017 and January 2018 and involved completion of counterweight repairs.

American Bridge Company has been selected as the general contractor to perform the next phase of bridge rehabilitation work and anticipates rehabilitation work will begin in early October 2018 and rehabilitation work will continue through December 2019.

As we prepare to begin rehabilitation work, please note the following significant dates:

Crews anticipate performing pre-construction assessment work Tuesday, **September 4, 2018** through Friday, **September 7, 2018** between the hours of **10 AM** and **2 PM** to document the current condition of the bridge mechanical systems, steel members, and in-water pile systems prior to the actual start of rehabilitation work.

During preliminary assessment work, crews may need to temporary lift the bridge or restrict vehicular, bicycle and pedestrian traffic across the bridge for short periods of time, i.e. traffic restrictions may be in 10-15 minutes increments over the course of the mid-day non peak traffic periods. Please expect minor intermittent traffic disruptions during this period.

Crews anticipate mobilizing into the area along the northern half of Terry A Francois Boulevard beginning the week of September 17, 2018 to set up a construction yard where the contractor will stage construction trailers, materials, and equipment. The block of Terry A Francois Blvd., between Third Street and the north east corner will be closed to through traffic for the duration of rehabilitation work. Access will be maintained for emergency vehicles, bicycles, and pedestrians, as well as "The Yard" and outdoor seating on the south side of the street.

Rehabilitation work on the bridge is anticipated to begin the week of **October 1, 2018**, starting with installation of containment scaffolding, pending favorable traffic and tide conditions.

Upcoming Impacts and Restrictions

The Third Street Bridge will operate normally and will be available to be lifted for maritime traffic until **September 17, 2018**. After this date, the bridge will be lowered and **locked in the down position** and will not be available for any lifts until completion of rehabilitation work in late 2019.

Kayaks and other similar sized vessels that can normally transit under the bridge in the down position may continue to do so. The United States Coast Guard will provide details of in-water work and temporary navigation changes in the Coast Guard Local Notice to Mariners.

During rehabilitation work, access across the bridge will be maintained for vehicle, bicycle and pedestrian traffic, except for instances where temporary full bridge closures are required. Please be aware that travel lanes may be reduced, restricted or altered as needed during different phases of rehabilitation work on the bridge.

At this time, the contractor does not anticipate a need for **full bridge closures** until **summer 2019**, though certain rehabilitation activities may require periodic short term full bridge closures.

Access to private or commercial buildings and pedestrian pathways on either side of the bridge will be maintained at all times, however, delays may be possible. Please observe all posted restricted parking and traffic signage and allow extra travel time through the area in case of traffic delays during construction.

We thank you for your patience and understanding as we prepare to begin rehabilitation of this historic San Francisco landmark.
