Notice of Upcoming Bridge Closure, Temporary Bicycle Lane and Parking Restrictions on Berry Street between Third and Fourth streets on select dates from July 08 – August 23, 2019

## Dear Third Street Bridge Neighbor,

San Francisco Public Works is in the process of performing ongoing rehabilitation work on the Third Street Bridge as part of the **Third Street Bridge Rehabilitation Project** (Contract No. 2317J).

The bridge will be closed on select dates from July 09 to August 23, 2019\* between Berry Street and Terry A. Francois Blvd. During the closure, access across 3<sup>rd</sup> Street Bridge will be **fully restricted** to all vehicle, bicycle and pedestrian traffic.

To accommodate rerouted bicycle traffic, **SFMTA will temporarily** install a protected westbound bicycle lane along the north side curb of Berry Street between 3rd and 4th streets. Parking spaces along Berry Street will be shifted to be adjacent to the temporary bike lane throughout the closure period. Some parking spaces adjacent to driveways will be temporarily unavailable to help improve visibility. Please **DO NOT** park or pull into the bicycle lane or crosshatched area at any time and utilize designated loading and unloading zones and parking spaces adjacent to the bike lane as needed. Trash dumpsters may be put in the parking spaces (not in the bike lane or crosshatched area) for collection as normal.

Following completion of rehabilitation work, normal parking conditions will be restored along the north side of Berry Street and the temporary bicycle lane will be removed. We strongly advise to plan ahead and take alternative routes should you need to navigate through the area during these dates.

Pedestrians traveling southbound: Bay Trail Path > 4th St > Channel St Pedestrians traveling northbound: Channel St > 4th St > Bay Trail Path Bicyclists traveling southbound: Berry St > 4th St > Channel St Bicyclists traveling northbound: Channel St > 4th St > Berry St Vehicles traveling southbound: King St > I-280 South > 18th St Vehicles traveling northbound: 16th St > 7th St > Brannan St

### Berry Street parking and bike lane configuration:



Parking spaces along the north side of Berry Street, between 3rd and 4th streets, will be shifted to accommodate a temporary curb side, parking protected bike lane during the bridge closure period.

#### **Impacts and Restrictions**

Automobile, bicycle and pedestrian access across the bridge will be unavailable during select dates as crews perform bridge rehabilitation activity. Waterway access under the bridge will remain accessible to kayaks. Access to private or commercial buildings and pedestrian pathways on either side of the bridge will be maintained at all times, however, delays may be possible.

**Right turns** onto **3<sup>rd</sup> Street from Berry** will be temporarily restricted during the closure, with the exception of vehicles accessing the **China Basin Parking Garage** entrance on 3rd.

"No Parking/Tow Away" signs will be posted 72 hours in advance of work starting, stating project work hours and parking restrictions. Please observe parking and traffic signage and allow extra travel time in case of traffic delays during construction. Vehicles parked in the construction zone during posted work hours will be towed at the vehicle owner's expense.

We thank you in advance for your patience as we complete these much-needed infrastructure repairs and as we work to make San Francisco safer for all residents. We apologize in advance for any inconvenience construction activity may cause.
