#### Questionnaire Results

We wanted to send an update regarding the California Laurel Village Streetscape Improvement Project. Since our first public meeting in March, we have compiled the responses to the questionnaire, listed below, and our team has begun working on design concepts for the two-block stretch. Due to the time needed to develop comprehensive concepts for presentation and review, as well as on-site analysis of existing traffic conditions, we are now expecting the next public meeting will be held late June or early July. - 4. The most common answers to what respondents Liked about Laurel Village were:
  - Wide sidewalks
  - Ease of parking
  - Street trees
- 5. The most common answers to what respondents Disliked about Laurel Village were:
  - The uneven, sloped sidewalk area between Cal-Mart and Starbucks
  - Existing clutter on the sidewalks (meter posts, newspaper racks, etc.)
  - Outdated, dreary, and tired were words used to describe the shopping center
  - Lack of seating
- 6. The most common answers to what respondents think would provide the best improvement to Laurel Village were:
  - More attractive and consistent environment
  - More planting/trees/greening
  - Benches/Seating
  - Flattening the sidewalks
