This Special Meeting of the Refuse Collection and Disposal Rate Board ("Rate Board") is to receive and consider a report from the Director of Public Works on the Abandoned Materials Collection Program and from the Department of the Environment regarding the Special Reserve Fund. These reports were requested by the Rate Board at its special meetings in July 2013 on the Rate Application filed by Applicants Recology Sunset Scavenger, Recology Golden Gate, and Recology San Francisco ("Recology").

This Special Meeting will commence on December 16, 2015, at 2:00 p.m. in City Hall Room 263, One Dr. Carlton B. Goodlett Place, San Francisco CA 94102. Public comment will be taken. After hearing presentations and public comment on the two reports, the Rate Board will deliberate and may take action on two items:

- (1) The Rate Board will consider adopting a finding, based on the report of the Director of Public Works, that the Abandoned Materials Collection ("AMC") Program has increased the diversion of abandoned materials from landfill in a cost-effective manner consistent with the City's goal of zero waste. If the Rate Board makes this finding, the July 2013 Resolution and Rate Order states that the AMC Program will continue after June 30, 2016, at the same rates as in the pilot program, subject to any adjustments authorized in the Rate Orders.
- (2) The Rate Board may determine, based on the report of the Department of the Environment, whether there is a continuing need for the Special Reserve Fund under the 1987 Waste Disposal Agreement. If some or all of the Fund is no longer needed as of the expiration of the 1987 Agreement, the Board will determine how the funds will be used.
