Subject: As-Needed Structural Engineering Services 2026 – Contract Awards

Director's Recommendation: Award five (5) Professional Services Contract for As-Needed Structural Engineering Services 2026, each in an amount not-to-exceed \$3,000,000 and with a duration of 1,825 calendar days to the following consultants: Biggs Cardosa Associates, Inc. / Bello & Associates, Structural Engineers Joint Venture (JV); Structus, Inc.; COWI North America, Inc. / Ryan Joyce Structural Design JV, ARUP US, Inc. / Maffei Structural Engineering JV, and SOHA Structural Engineers for structural engineering services. Approve an increase of \$1,500,000 contingency to the total contract not-to-exceed amount, increasing the total not-to-exceed amount to \$4,500,000, and authorize the Director of Public Works to approve the corresponding future contract modifications. Per contract.

Contract Background: The work to be done under these contracts consist of structural engineering services. The selected consultants provide specialized services in structural engineering tasks that may include, but need not be limited to, structural design and analysis of buildings and structures, soil-structure interaction, non-linear analysis, condition assessment reports, field investigations, peer reviews, forensic engineering, bridge engineering, corrosion engineering, value engineering, cost estimating, construction engineering, and consultation for various types of structures in high seismic regions. Consultants may provide the requested services for an entire project, a portion of a project, or any project phase.

Each contract has a term of five-year term with an initial not-to-exceed amount of \$3,000,000. According to San Francisco Administrative Code Section 6.43(b)(1), cumulative modifications to a multiple-project as-needed contract shall not exceed 150% of the original not-to-exceed contract amount. Therefore, each contract may be increased by up to \$1,500,000, bringing the total not-to-exceed amount to \$4,500,000 per contract.

Solicitation Process: On December 10, 2025, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Structural Engineering Services 2026. Public Works sought to award five (5) contracts with an anticipated not-to-exceed contract amount of \$3,000,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) established a 15% Local Business Enterprise (LBE) subcontracting requirement for each contract awarded under the RFQ.

On February 4, 2026, Public Works received nine proposals. City staff reviewed the proposals and determined that all nine (9) proposals were deemed responsive and responsible. The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter. Optional oral interviews were not conducted.

Based on the evaluation results, Public Works recommends awarding contracts to the top five (5) ranked proposers.

WHEREAS, Public Works issued the RFQ to award five (5) contracts to pre-qualified prime consultants or joint ventures, each with an initial contract amount not to exceed \$3,000,000, a duration of 1,825 calendar days, and a contingency amount of \$1,500,000; and

WHEREAS, The Contract Monitoring Division established a 15% Local Business Enterprise (LBE) subcontracting requirement for each contract awarded under the RFQ; and

WHEREAS, On February 4, 2026, Public Works received nine (9) proposals in response to the RFQ; and

WHEREAS, All nine (9) proposals were deemed responsive and responsible and were evaluated and scored by a panel, without oral interviews; and

WHEREAS, Proposer Biggs Cardosa Associates, Inc./Bello & Associates Structural Engineers, Joint Venture (“Biggs Cardosa/Bello, JV”) ranked first among the proposals evaluated in response to the RFQ; and

WHEREAS, Public Works seeks authorization to award a contract to Biggs Cardosa/Bello, JV for As-Needed Structural Engineering Services 2026; now, therefore, be it

RESOLVED, That this Commission hereby awards a Public Works Professional Services Contract to Biggs Cardosa/Bello, JV in an amount not-to-exceed \$3,000,000, with a contract duration of 1,825 calendar days, and approves a \$1,500,000 contingency, for a total not-to-exceed contract amount of \$4,500,000.

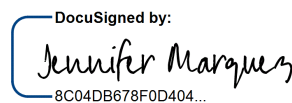
