**An appeal must be based on one or more of the following grounds:**

1. The Department of Public Health incorrectly determined that the Application complies with the Public Health Compliance Standard (Public Works Code Section 1507(b)).
2. The Application does not meet the applicable Compatibility Standard for the following reason(s) (delete those that do not apply):
  - a. Public Works improperly determined that the Application meet the Objective Standards adopted by Public Works in Public Works Order No. \_\_\_\_\_.
  - b. The Planning Department incorrectly determined that the Application meets the applicable Tier A and/or B Compatibility Standard (Public Works Code Section 1509(b)).
  - c. The Department of Recreation & Parks incorrectly determined that the Application meets the Tier C Compatibility Standard (Public Works Code Section 1510(b)).
