**PLEASE TAKE NOTICE** that Public Works has tentatively approved the issuance of a Surface-Mounted Facility Site Permit for a Stand-alone Pole for a Personal Wireless Service Facility to [Applicant Name] at the following location: [List the address]. At the hearing, you will have the opportunity to express your concerns about the proposed Surface-Mounted Facility.
