- Welcome and Introductions: Chair Larry Stringer (seat DPW) welcomed Board members and other attendees. Each member and guest introduced themselves. Members checked attendance and established there is not quorum at this time.

- Public Comment:
  - Greg Dillon commented on the issue of the lack of timelines in abating graffiti by companies like AT&T and PG&E
    - Procedures of private graffiti SR's are labor intensive; involve site visits, sending certified mail
    - 19<sup>th</sup> and San Carlos and Lexington; February 2015, reported and closed a day later – 29 of these reports on same graffiti; March, April, June...
    - Frustrating that the reports are getting closed without being resolved
    - Suggestion: make pge & att close out the report once they have actually cleaned the graffiti
    - 3-1-1 states responsible agency for curbs is Public Works.
  - Public Works staff informed Greg that Public Works will be looking into the Service Request issue brought up by Greg with 311, ATT & PG&E
    - Follow-up note: the graffiti in these reports is located on a curb but it is not a street curd. The curb is actually located on PG&E property. Public Works did a courtesy abatement.
    - Public works staff will follow more closely if multiple reports of the same graffiti.
  - Public comment is closed
- Review and approval of the draft <u>November</u> 2015 GAB minutes
- Chair's Report:
- **DPW stat report numbers:** For the period of December 2015 are not yet available
- In <u>November</u> 2015 Public Works staff issued 509 new private property graffiti NOVs (compared to 460 in November 2014), of which 86.1% have been owner abated.
- Of the new NOV cases in <u>November</u> 2015, districts 5 (Inner Sunset, Haight, Western Addition), 6 (Tenderloin, SOMA, Civic Center), and 9 (Mission, Bernal Heights, Portola) received the most new NOV's with 77 in D5, 126 in D6, and 73 in D9.
- DPW reports show that 36 cases of private graffiti NOVs have gone to blight in November 2015. This number is down considerable from the same time last year with 89 NOV to blight cases
- **Membership update:** The revised ordinance, introduced by Supervisor Breed, changing the one SFMTA seat to an "At-Large (seat #18)" of Graffiti Advisory Board was heard today at the Rules Committee hearing and was passed and will go to the full board at the next board meeting
  - Vacant/inactive seats: seat #4, #6, #13, SFDA and SFMTA-MUNI

- New Business:
  - a) Precita Eyes Mural Center Todd Berman (seat 9) (discussion item)

-Todd Berman stated:

- Precita Eyes is facing eviction from the location where they have been for many years
- They have been a champion of mural programs throughout the Mission and city
- They have a strong youth arts program
- They are a vandalism prevention organization
- There are programs and efforts to raise money to help them purchase their building on Precita
- Proposed GAB support or encourage that the city and others help support the effort of helping Precita Eyes remain in their location

-A letter submitted by GAB member Office Ferreira (SFPD), who could not attend today's meeting was read to the board.

-The letter stated:

- He supports freedom of speech and the first amendment but as a San Francisco Police Officer heading up the graffiti vandalism unit he does <u>NOT</u> support Precita Eyes
- He submitted several screen shots from an Instagram account with the user name Precita Eyes
- This account appears to promote graffiti tags that have plagued the city of San Francisco for many years
- o This account also feature various graffiti crews including "KHY"
- Based on his experience as a San Francisco Police offers he has seen tens of thousands of dollars of graffiti vandalism caused by such vandals

• Stated that as long as Precita Eyes receives public funding their group should be transparent and member and associate held accountable

-Todd stated that there appears to be "guilt by association" and he will find out if this Instagram account is the official account of Precita Eyes

-The Precita Eyes organization and its Youth Arts Program which is house in the Precita location is a program teaching you how to create murals

-KHY is an anti-gentrification symbol and could be used by multiple various individuals and not necessarily associate with Precita Eyes -We should be encouraging the positive aspect of what Precita Eyes is doing and not build on this aspect of it

-KHY graffiti sees this symbol as positive for the neighborhood whereas Precita Eyes does the same by way of putting murals up

-whenever there is something positive being done we should recognize that aspect of it

-the point here is that the building in questions is the home for the Youth Arts Program which teaches you how to accomplish putting up art through the process of getting permission

-the goal of the program is to paint permitted murals in an effort to avoid or prevent graffiti vandalism and some of the taggers listed actually tag over murals and art which is not what Precita Eyes teaches

-It was brought up that when Precita Eyes holds its annual Urban Art Festival at Precita Park:

-they are not asking people artist to wear protective gear such as face mask while spraying

-they give away cans of spray paint

-the area around the festival, public and private property, gets bombed with graffiti vandalism

-as an organization, they should be teaching the individuals attending the Urban Art Festival right from wrong and respect for other people's property

-this body has reached out to Susan at Precita Eyes to come to the GAB meeting to discuss some of the issues pertaining to what the organizations does and how they fell about vandals who appear to be associated with the Precita Eyes organization

- We would like Todd to reach out to Precita Eyes and ask Susan to come to the Graffiti Advisory Board to present soon as the Board has some concerns and we would like to hear from Precita Eyes before moving forward on any type of action

b) Corporate graffiti vandalism – Todd Berman (seat 9) - (discussion item)

-Todd stated in referring to the recent Justin Bieber that corporate graffiti is worse than an individual tagging something on a wall as an act of individual expression in a misguided way

-Todd suggested that the City go after these corporate sponsored graffiti vandals with criminal charges instead of just a fine as this is more than \$400 in vandalism and felony vandalism

-Suggested that vandalism by advertisers is a greater affront to San Francisco than graffiti vandalism by individualism whose intent is to self expression rather than profit

- Members of the board expressed disagreement with Todd's statement that corporate vandalism is worse that individual vandalism.

-member stated all graffiti vandalism is equally bad for San Francisco and there would be nothing to gain for this body to state that one type of graffiti vandalism is worse than another and the law should be applied equally

-members did agree that we should continue hit the corporate vandals where it hurts and that is in the pocketbook through steep fines - the question would be could you bring a corporation to criminal court for felony graffiti vandalism

Adjournment: The meeting was closed at 4:45 p.m.

**Next Meeting Date**: The next Graffiti Advisory Board meeting is scheduled to be held on **Thursday, February 11, 2016** at 30 Van Ness Avenue, 5th Floor, in DPW's Department of Engineering Main Conference Room.

The three subcommittees have been suspended starting August 2015 in order for the board to focus on the 2016 Huddle.

The 2016 huddle subcommittee will meet from 2:30 pm – 3:30 pm (just prior to the subcommittee meetings)
