
### \$412.3M General Obligation Bond Authorized in June 2010 with approval by 79.4% of voters

#### **General Description**

- Fire Station No. 16 was built in 1938, located in District 2, on Greenwich Street between Steiner & Fillmore Streets
- The existing two story building currently accommodates two Apparatus Bays
- The proposed design will accommodate two Apparatus Bays for three fire trucks and 2 shifts of 8 firefighters with support services and sleeping quarters




# ESER 1 Neighborhood Fire Stations Station #16 Bubble Diagram



### ESER 1 Neighborhood Fire Stations Station #16 First Floor Plan






