## a. Western Addition Area Traffic Signal Upgrades: Phase 1 – Construction Contract Award

Award the Western Addition Area Traffic Signal Upgrades: Phase 1 contract to Bay Area Lightworks, Inc. in the amount of \$6,100,000 with a contract duration of 548 consecutive calendar days to perform traffic signal-related safety improvements at 16 locations in the Western Addition Area.
