6. **Castro Station Elevator Construction – Contract Award**

Staff Recommendation: Approve the proposed resolution awarding the Castro Station Elevator Project contract to CLW Builders, Inc. in the amount of \$11,540,000, with a \$115,400 contingency and a contract duration of 600 consecutive calendar days. On July 9, 2021, the activities encompassed under the contract were determined to be exempt from the California Environmental Quality Act (CEQA) under the Class 11 categorical exemption (CEQA Guidelines Section 15311), as described in the CEQA Exemption Determination (Case No. 2018-005547ENV) contained in the Commission's files for this contract.
