## 10 DAY NOTICE OF CONSTRUCTION

October 7, 2019

Dear Jefferson Street Neighbors/Businesses,

This notice is to remind you that the Jefferson Streetscape Improvement Project - Phase II is anticipated to begin construction activity soon in your neighborhood. The project limits will be **Jefferson Street from Jones Street to Powell Street** in San Francisco, California.

Construction activity is anticipated to be completed in four sequences\* in an effort to consolidate and minimize impacts. (Please visit the project webpage noted below for detailed sequencing information.)

- **Sequence I:** (Fall 2019 to Winter 2020)
  - o Work focused at the intersection of Jefferson and Jones Street
- **Sequence II:** (Winter to Spring 2020)
  - o Work focused along the north sidewalk of Jefferson, Jones to Powell
- **Sequence III:** (Spring to Summer 2020)
  - o Work focused along the south side sidewalk of Jefferson, Jones to Powell and Plaza
- **Sequence IV:** (Summer to Fall 2020)
  - o Roadway reconstruction on Jefferson, Jones to Powell

Construction for **Sequence I** is anticipated to begin the week of **October 21, 2019\*** at the intersection of **Jefferson and Jones**. Anticipated scope of work in this sequence will consist of: utility, electrical, lighting, sidewalk, landscaping and roadway work.

**General Work Hours:** Monday to Friday 7:00 AM to 4:00 PM\*
