Subject: As-Needed Architectural Services for Health Facilities No.3, Contract ID 1000027302 - Contract Modification

Director's Recommendation: Approve Modification to As-Needed Architectural Services for Health Facilities No.3, Contract ID 1000027302 with Perkins Eastman Architects, DPC to increase the not-to-exceed contract amount by \$1,000,000 for a new not-to-exceed amount of \$3,000,000.

Contract Background: Perkins Eastman Architects, DPC, with its team of sub-consultants, shall provide architectural and multi-discipline design services involving renovation, relocation, adaptive re-use of existing health facilities, installation of specialized medical equipment, modifications to life safety systems and other infrastructure, and new health facilities. Consultant may provide the requested services for an entire project, a portion of a project, or a project phase.

Reason for Modification: The proposed modification would increase the contract amount by \$1,000,000. The additional contracting capacity will be used to award additional contract service orders under the As-Needed Architectural Services for Health Facilities No.3 on an as-needed basis. These as-needed contract service orders are necessary to support Public Works staff with their workload and to harness the consultant's specialized services.

Subject: Modification No. 5 for 1000027302 - As-Needed Architectural Services for Health Facilities No. 3

Public Works ("PW") has requested a modification for the above referenced contract by increasing the contract amount by \$1,000,000 for a total agreement amount of \$3,000,000. Per the Prime Consultant, Perkins Eastman Architects ("Perkins Eastman"), the scope of work for Modification No. 5 consists of continuing their A/E work under their agreement.

LBE Subcontracting Participation

The LBE subcontracting participation requirement established for this contract is 20%. The subcontracting participation requirement applies to the entire contract including any amendments, change orders and modifications. As of 11/11/2025, Perkins Eastman has invoiced \$1,327,229.56. The LBE participation on Perkins Eastman's CMD Form 2A at the time of proposal and the LBE participation achieved to-date is as follows:

On As-Needed contracts, the project team is assembled based on the anticipated needs outlined in the RFP. However, the extent to which firms are utilized will vary depending on the department's needs during the contract term. Per Perkins Eastman, excluding Bellow & Associates, the LBEs with 0% participation to-date were not required on any CSOs issued to-date.

Bello & Associates ("Bello"), listed to perform structural engineering, was not utilized due to disagreements with the subcontract terms. Per the email correspondence provided by the prior CMD Representative, Selormey Dzikunu, after numerous failed attempts to come to an agreement with Bello, Perkins Eastman added LBE firm, Ryan Joyce Structural Design, to perform structural engineering services.

Projected LBE Participation

Due to the nature of As-Needed contracts, LBE participation is determined by the PW assignments issued throughout the master agreement, therefore, it is impossible to provide an exact LBE projection. Perkins Eastman's current LBE projection is as follows:

The projected LBE participation in the above table is based on anticipated LBE work under executed CSOs. With the additional contract capacity authorized through Modification 5, Perkins Eastman will continue to assign work to their listed LBE subcontractors as additional tasks are authorized.

In 2024, CMD investigated a complaint from an LBE regarding delayed payment by Perkins Eastman. CMD has since warned Perkins Eastman that it must comply with the City's Prompt Payment Provisions. Under the San Francisco Administrative Code, Chapter 14B.7(H)(9)(A) and (B), prime contractors are required to pay their subcontractors within three (3) working days of receiving payment from the City. Furthermore, subcontractor payment requests must be included in the prime's payment application to the City within 30 days. Failure to comply with the City's Prompt Payment Provisions may result in CMD imposing any of the following sanctions:

- (1) Declare a Bid non-responsive;
- (2) Suspend a Contract;
- (3) Withhold Contract payments;

- (4) Assess contractual or statutory penalties;
- (5) Debar a Bidder under Chapter 28;
- (6) Revoke certification

Going forward, PW staff and Perkins Eastman will continue to obtain CMD approval for each subcontractor addition and LBE substitution in accordance with established procedures. Additionally, to ensure compliance with the LBE ordinance and requirements, PW and Perkins Eastman must notify CMD of any changes to the scope of work as well as any changes to information previously provided to CMD. Contingent on the conditions set forth above, CMD approves the subject modification.
