Call to Order, Roll Call and Agenda Changes

Chair Lauren Post called the meeting to order at 11:04 a.m.

On the roll call, commissioners Eleanor Blume, Lauren Post, Gerald Turner, Paul Woolford and Fady Zoubi were present.

With five members present, the Commission met quorum.

Key staff present: Director Carla Short, Deputy City Attorney Christopher Tom and Commission Secretary Bob Fuller.

1. Announcements by Chair, Commissioners and Secretary

Heard by the Commission. Speaker: Chair Lauren Post.

- **Chair Post** highlighted the message in the correspondence log praising staff for their courteous and effective response.
- Posed questions to Director Short about the impact of federal and state funding changes to the Department's budget.
- Discussed the November "In the Works" newsletter.
- Praised the Department for filling nearly all leadership vacancies and converting multiple positions to permanent from temporary status.
- Announced her resignation from the Public Works Commission following this meeting.

- **Director Short** thanked Chair Post for her service to the Commission.
- Discussed illegal vending legislation approved by the Board of Supervisor and signed by the mayor to target the sale of fenced goods.
- Reported on proposed commercial regulations reforms, specifically the introduction of an in-lieu fee for developers as an alternative to requirements to plant trees as part of a development.
- Discussed planting of fifteen trees with SOMA Philippines in the South of Market neighborhood.
- Announced the retirement of Bureau of Urban Forestry Urban Forester Chris Buck after twenty years of service.
- Announced the plan to have the next phase of the Earthquake Safety and Emergency Response bond program on the ballot in 2026.

- Reported that the City's Health Services agency recognized Public Works with a platinum award for wellness at work efforts.
- Announced that Maura Wayne who had been the acting superintendent of the Bureau of Building and Street Repair accepted the role on a permanent basis.
- Previewed the 2026 calendar of [Love Our City](#) neighborhood beautification days, starting in District 5 on January 10th.

- Sean Auckland of Fairtrees.org argued that the City is netting a loss of trees in the urban canopy each year and that Public Works is not serving the South of Market neighborhood.
