**Subject:** As-Needed Civil Engineering Services for Curb Ramp Design Work 2026 (Micro-LBE Set-Aside Program)  
- 3 Contract Awards

**Director’s Recommendation:** Award Professional Services Contract, As-Needed Civil Engineering Services for Curb Ramp Design Work 2026 (Micro-LBE Set-Aside Program) in the amount of \$2,000,000 each for 1,825 calendar days to the following 3 contracts (each a “Consultant”): AGS, Inc., SAGE Consulting Engineers, Inc., and Water Resources Engineering, Inc. for civil engineering curb ramp design services. Approve an increase of \$1,000,000 contingency to the total contract not-to-exceed amount and authorize the Director of Public Works to approve future contract modifications, increasing the total not-to-exceed amount to \$3,000,000 per contract.

**Contract Background:** The work to be done under this contract consists of specialized services in Civil Engineering, specifically Curb Ramp Design, to support Public Works’ design staff on an as-needed basis. Work shall include data collection and designing compliant curb ramps per City standards and Americans with Disabilities Act requirements, related land surveying, roadway, sewer, drainage design, and other curb ramp-related consultation services.

Each master agreement has a term of five-year term with an initial not-to-exceed amount of \$2,000,000. According to San Francisco Administrative Code Section 6.43(b)(1), cumulative modifications to a multiple-project as-needed contract shall not exceed 150% of the original not-to-exceed contract amount. Therefore, each contract may be increased by up to \$1,000,000, bringing the total not-to-exceed amount to \$3,000,000.

**Solicitation Process:** On October 30, 2025, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Civil Engineering Services for Curb Ramp Design Work 2026 (Micro-LBE Set-Aside Program). Public Works sought to award 5 contracts with an anticipated not-to-exceed contract amount of \$2,000,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) waived the Local Business Enterprise (LBE) subcontracting requirement for this contract as a Micro-LBE Set-Aside Program.

On December 11, 2025, Public Works received five proposals. City staff reviewed the proposals and determined that four proposals were responsive and responsible.

The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter. One proposal did not achieve the required minimum score for contract award.

Optional oral interviews were not conducted.

The top RFQ proposers for this contract were the following three: AGS, Inc., SAGE Consulting Engineers, Inc., and Water Resources Engineering, Inc.

WHEREAS, On October 30, 2025, San Francisco Public Works (Public Works) issued a Request for Qualifications (RFQ) As-Needed Civil Engineering Services for Curb Ramp Design Work 2026 (Micro-LBE Set-Aside Program) to establish a pool of qualified consultants; and

WHEREAS, The not-to-exceed contract amount is \$2,000,000; and the contract will have a duration of 1,825 calendar days; and

WHEREAS, Public Works seeks authorization to increase the contract amount by \$1,000,000 to the not-to-exceed amount, resulting in a revised not-to-exceed amount of \$3,000,000; and

WHEREAS, Public Works intended to award five contracts to pre-qualified prime consultants or joint ventures through the RFQ; and

WHEREAS, This Contract was solicited as a Micro-LBE Set-Aside Contract under Chapter 14B of the San Francisco Administrative Code, for which no separate LBE subcontracting participation requirement applies; and

WHEREAS, On December 11, 2025, Public Works received five proposals in response to the RFQ; and

WHEREAS, Four proposals to be responsive and responsible, and were evaluated and scored by a panel composed of individuals knowledgeable on the subject matter of this RFQ; and oral interviews were not conducted; and

WHEREAS, Three proposers achieved the minimum score required for contract award; and

WHEREAS, AGS, Inc. ranked first in the RFQ; now, therefore, be it

RESOLVED, That this Commission hereby awards Public Works Professional Services Contract in an amount not-to-exceed \$2,000,000, with a contract duration of 1,825 calendar days, to AGS, Inc.; and

FURTHER RESOLVED, that this Commission hereby approves the contingency increase, resulting in a revised not-to-exceed amount of \$3,000,000.
