Contract Modification

Director's Recommendation: Approve Modification to As-Needed Waterproofing Services No. 4, Contract ID 1000030139 with Allana Buick & Bers, Inc. to increase the not-to-exceed contract amount by \$350,000 for a new not-to-exceed amount of \$1,050,000.

Contract Background: The Public Works Commission awarded this contract on September 15, 2023, with Resolution 2023-0087. Under this contract, Allana Buick & Bers, Inc. ("Consultant"), with its team of sub-consultants, provides waterproofing services, and other related services on an as-needed basis. Services to be performed include, but are not limited to, recommend systems and review drawings and specifications of waterproofing details and specifications to reduce the risk of water intrusion. In addition, Consultant provides field observations during construction to ensure that the construction is proceeding per the drawings and specifications in relation to waterproofing. Consultant may provide the requested services for an entire project, a portion of a project, or a project phase.

Reason for Modification: The proposed modification would increase the contract amount by \$350,000. The additional contracting capacity will be used to award additional contract service orders under the As-Needed Waterproofing Services No. 4 on an as-needed basis. These asneeded contract service orders are necessary to support Public Works staff with their workload and to harness the Consultant's specialized services.
