**Executive Summary:** Per the Sanitation and Streets Commission Rules of Order – Article III, Section 3 - the Commission shall establish a calendar of regular meetings for the forthcoming year prioritizing public access and participation balanced with the availability of commissioners, Department staff and meeting rooms. The schedule of regular meetings will be posted to the Commission's website and amended promptly if changed by the Commission.

**Summary of Proposed Commission Action:**

- The Sanitation and Streets Commission will establish regular meeting dates quarterly on the third Monday of the month, starting at 10 a.m., with exceptions to accommodate holidays.
- Meetings may be cancelled during the year.
- Should additional meetings need to be scheduled, Article III, Section 4 of the Sanitation and Streets Commission Rules of Order state that special meetings may be called at any time by the Chair or by the majority of members.
- Once approved by the Sanitation and Streets Commission, the meeting schedule will be posted on-line and notice for all meetings will be posted in accordance with public meeting laws.
