Subject: San Francisco Municipal Transportation Agency Garage Elevator Modernization - Phase 2A – Contract Award

Director’s Recommendation: Award construction contract for San Francisco Municipal Transportation Agency Garage Elevator Modernization Phase 2A in the amount of \$4,338,000 with a contract duration of 1,140 consecutive calendar days to W.E. Lyons Construction Co. to modernize two elevators at the St. Mary’s Square Garage and four elevators at the Ellis O’Farrell Garage.

Contract Background: San Francisco Municipal Transportation Agency (“SFMTA”) operates several high-use garages across the San Francisco, including Ellis O’Farrell Garage and St. Mary’s Square Garage. The elevator systems in these facilities have significantly aged, resulting in increased maintenance issues, outdated components, and reduced reliability.

This project will modernize the elevators at both garages with new code-compliant systems that improve safety, performance, and operational uptime. The effort aligns with SFMTA’s commitment to maintaining safe, accessible, and dependable public facilities. Elevators to be modernized under this contract are located at the following locations:

1. St. Mary’s Square Garage - 433 Kearny Street, San Francisco, CA 94108
2. Ellis O’Farrell Garage - 123 O’Farrell Street, San Francisco, CA 94102

Solicitation Process: The solicitation package, including the project design and technical specifications, was publicly advertised on June 12, 2026. A pre-bid meeting was conducted on June 30, 2026 at both project sites to review existing site conditions and provide prospective bidders an opportunity to ask questions and request clarifications.

Bids were received on July 15, 2026. Contract Administration completed a detailed evaluation of all cost items listed in the bid form. A qualification review of the lowest responsive bidder was subsequently conducted, confirming that the bidder met all required criteria for contract award.

WHEREAS, On March 28, 2023, San Francisco Public Works entered into an agreement with the San Francisco Municipal Transportation Authority (“SFMTA”) to manage the design and construction of the SFMTA Elevator Modernization Project (“Project”) – Phase 2A located at 433 Kearny Street (St. Mary’s Square Garage) and 123 O’Farrell Street (Ellis-O’Farrell Garage); and

WHEREAS, On April 23, 2026, the Planning Department determined that for purposes of the California Environmental Quality Act (“CEQA”), the Project is not defined as a project under CEQA Guidelines Sections 15378 and 15060(c)(2) because it does not result in a physical change in the environment; and

WHEREAS, On November 24, 2025, the Project was submitted to the San Francisco Department of Building Inspection for a construction permit application, the application was approved on December 17, 2025; and

WHEREAS, On June 12, 2026, Public Works advertised the Project; and

WHEREAS, On July 15, 2026, Public Works received five bids; and

WHEREAS, Public Works staff reviewed the bids and determined that W. E. Lyons Construction Co is the responsible bidder with the lowest responsive bid; and

WHEREAS, The bid from W. E. Lyons Construction Co. included a base bid for construction of \$4,338,000 and an elevator maintenance agreement of \$187,200 for a total bid amount of \$4,525,200; and

WHEREAS, A portion of the base bid in the amount of \$4,338,000 is for the elevator modernization work to be awarded by Public Works; and

WHEREAS, A portion of the base bid in the amount of \$187,200.00 is for elevator maintenance work, to be awarded separately by the Real Estate Division when the construction work is substantially completed; and

WHEREAS, The Local Business Enterprise Sub-contracting requirement was waived by the Contract Monitoring Division; and

WHEREAS, Funds are available from SFMTA Revenue Funds; now, therefore, be it

RESOLVED, That this Commission hereby approves the award of a contract for San Francisco Municipal Transportation Agency Garage Elevator Modernization – Phase 2A, in the

amount of \$4,338,000 and a contract duration of 1,140 consecutive calendar days to W.E Lyons Construction Co.

Elevator modernization is replacement of the “Brain” and related equipments of the elevator. It does not involve any demolition or soil disturbance of any kind.,

Here is the description of the project scope as permitted by DBI.

Project Scope

- Modernization of four (4) Elevators at 123 O’Farrell Street (Ellis O’Farrell Garage)

Upgrade to Elevators #1, #2, #3 & #4

- New Machines, microprocessor-based controllers, digital landing systems and new suspension (basically the brain)
- New door operating equipment, guide rollers, wiring in machine room and hoistway. Some operating fixtures and other related items will be refurbished to “as new” condition.

Additional Work includes

- Providing 2-way emergency interactive video/Text based communication system (per CBC 3001.2) in elevator car control panel
- Replacement of existing pit ladders as required.
- Some electrical and mechanical system upgrades
- Removal of some fire sprinklers in traction elevator machine room
