Subject: As-Needed Geotechnical Engineering Services 2026 - Award of 3 Professional Services Contracts

Director's Recommendation: Award one professional services contract, each an As-Needed Geotechnical Engineering Services contract in the amount of \$3,000,000 for 1,825 calendar days, to each of the following 3 contractors (each a "Consultant"): AGS, Inc., Divis Consulting, Inc., and ENGEO Incorporated for geotechnical engineering services; and authorize the Director of Public Works to approve future contract modifications, increasing the total not-to-exceed amount to \$4,500,000 per contract.

Contract Background:

Each contract has a term of five years or 1,825 calendar days with an initial not-to-exceed amount of \$3,000,000.00. According to San Francisco Administrative Code Section 6.43(b)(1), cumulative modifications to a multiple-project as-needed contract shall not exceed 150% of the original not-to-exceed contract amount. Therefore, each contract may be increased by up to \$1,500,000.00, for a maximum not-to-exceed amount of \$4,500,000.00.

The work to be performed under these contracts consists of geotechnical engineering services. The selected consultant provides specialized services in geotechnical engineering tasks that may include, but need not be limited to, conducting geotechnical field explorations, investigations, and laboratory testing; supplemental testing such as seismic borehole logging, seismic refraction profiling, and corrosion testing and evaluation; preparing reports for new and existing building/bridge foundations; recommendations for designing foundation systems, excavation support and underpinning systems, retaining wall systems, embankments, and ground improvements such as grouting, deep soil mixing and dewatering; and other geotechnical/geological consultation related work, and will be provided on an as-needed basis. Services may be requested for the entire project, a portion of a project, or a specific project phase. Work will be authorized through individual Contract Service Orders based on project needs and available funding. Award of a contract does not guarantee any minimum amount of work.

Solicitation Process: On January 7, 2026, San Francisco Public Works advertised the Request for Qualifications As-Needed Geotechnical Engineering Services 2026. Public Works sought to

award 4 contracts, each with an anticipated not-to-exceed contract amount of \$3,000,000.00 with a contract duration of 1,825 calendar days.

The Contract Monitoring Division established a 15% Local Business Enterprise subcontracting requirement for each contract.

Public Works received 4 proposals by the submission deadline. City staff reviewed the proposals for responsiveness and determined that 3 proposals were responsive and responsible. The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter; oral interviews were not conducted.

Based on the evaluation results, the 3 highest ranked proposers are recommended for award.

WHEREAS, On February 18, 2026, Public Works received 4 proposals in response to the RFQ; and

WHEREAS, Three proposals were deemed responsive and responsible, and were evaluated and scored by a panel composed of individuals knowledgeable on the subject matter of this RFQ; and oral interviews were not conducted; and

WHEREAS, Proposer Divis Consulting, Inc. ranked second in the RFQ; and

WHEREAS, The not-to-exceed contract amount is \$3,000,000 and the contract duration is 1,825 calendar days; and

WHEREAS, Public Works seeks authorization to increase the contract amount by \$1,500,000 to the not-to-exceed amount, resulting in a revised not-to-exceed amount of \$4,500,000; now, therefore, be it

RESOLVED, That this Commission hereby awards Public Works Professional Services Contract in an initial not-to-exceed amount of \$3,000,000, with a contract duration of 1,825 calendar days, to Divis Consulting, Inc.; and be it

FURTHER RESOLVED, That this Commission hereby approves the contingency increase, resulting in a total not-to-exceed amount of \$4,500,000

REVISION NOTE

This CMD Review Memo has been revised per Department of Public Works request in order to add subcontractors for proposer ENGEO. This memo is intended to assist SF Public Works in setting up the PeopleSoft Project Team accurately. These firms are non-LBE subcontractors listed on ENGEO's team in their proposal. CMD has approved the subcontractor additions for these firms. Revision 2 of this memo has been issued to account for AGS, Inc.'s subcontractor addition. Revision 3 of this memo updates several non-LBE subcontractor business names to reflect the following: Traffic Management, Inc. is now operating as Traffic Management LLC and Geo-Ex Subsurface Exploration is now operating as Drill X Subsurface Corporation. Revision 4 of this memo accounts for a name change for non-LBE Enthalpy Analytics which is now Onterris Laboratories, LLC.
