Unfortunately, this incident is not isolated; there are many similar instances throughout the city, and I believe the lack of accountability for homeowners regarding the maintenance of these clean outs is a pressing issue.

While I understand that the responsibility for these clean outs may lie with individual homeowners, it appears that they are not being adequately held accountable by the city.
