I attended the last two meetings of the Commission and stepped up to make public comments on the extremely dire state of the streets in SOMA. I have been a resident and property owner here since 2006.

Below you will find a video taken today on Natoma Street that illustrates the problem. The SOMA part of D6 is in CRISIS when comes to our health and safety, and it needs CRISIS INTERVENTION to bring solutions. The filth and degradation of our neighborhood is affecting our quality of life, and we are not seeing improvements.

What are we to do? Our elected officials are not paying attention and doing NOTHING. We pay thousands and thousands of dollars in property taxes to have city services that we are NOT RECEIVING.

Perhaps we should sue San Francisco for not providing the minimum standard of services. Perhaps we should receive a huge discount on our property taxes. Perhaps everyone at City Hall should be fired.

The bottom line is we would like the city to do its job. Sometimes even the mayor is expected to do actual work and roll up her sleeves. She has no inclination to do so and has no clue on the state of San Francisco streets.

I hope you forward this email and video to all the commissioners so they can be informed about our situation and recommend action to the DPW.

We cannot live like this and continue being ignored.
