Subject: As-Needed Elevator Design Services No. 4. - Three Contract Awards

Director's Recommendation: Award Professional Services Contract, As-Needed Elevator Design Services No. 4 in the amount of \$1,000,000 each for 1,825 calendar days to the following three contracts (each a "Consultant"): Syska Hennessy Group, Inc., KP Elevator Consulting, LLC, and JE Sellen Consulting, LLC for elevator design services.

Contract Background: The work to be performed under this contract consists of elevator design services. On an as-needed basis, each Consultant would provide elevator design consultation services to ensure that our projects achieve the highest quality in elevator design. Tasks would involve analysis of the building population, traffic, use and travel times required for elevators. The Consultant would also provide specifications and coordinate with the Architects and Engineers to ensure the appropriate number and type of elevators are specified and employed for the project. Consultant may provide the requested services for an entire project, a portion of a project, or any project phase. Consultants have provided these types of services for the City in the past.

Solicitation Process: On April 15, 2024, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Elevator Design Services No. 4. Public Works sought to award three contracts with an anticipated not-to-exceed contract amount of \$1,000,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) waived the Local Business Enterprise (LBE) subcontracting requirement for this contract.

On May 29, 2024, Public Works received four proposals. City staff reviewed all proposals and determined that all four proposals were responsive and responsible.

The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter.

Optional oral interviews were not conducted.

Based on the panel's evaluation and scoring, the top three RFQ proposers for this contract are: Syska Hennessy Group, Inc., KP Elevator Consulting, LLC, and JE Sellen Consulting, LLC.

WHEREAS, All four responsive and responsible proposals were evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter of the RFQ; and

WHEREAS, Optional oral interviews were not conducted; and

WHEREAS, Syska Hennessy Group, Inc.'s proposal ranked first; now, therefore, be it

RESOLVED, That this Commission hereby awards Public Works Professional Services Contract, As-Needed Elevator Design Services No. 4, in an amount not to exceed \$1,000,000 and with a contract duration of 1,825 calendar days, to Syska Hennessy Group, Inc.
