Subject: Mission Branch Library Renovation - Contract Award

Director's Recommendation: Award Mission Branch Library Renovation contract in the amount of \$23,020,000 for 730 consecutive calendar days to S.J. Amoroso Construction Co., LLC to perform a complete renovation and expansion of the Mission Branch Library.

Contract Background: The Mission Branch Library is located at 300 Bartlett Street, San Francisco, CA 94110. The building fronts 24th Street and is bounded by Bartlett Streets and Orange Alley. Built in 1916, the Mission Branch Library is one of seven San Francisco Carnegie libraries and was designed by Beaux Arts architect G. Albert Lansburgh and is designed in the Italian Renaissance Revival style. The main entry was originally centered on the façade (now relocated to a side entrance) followed by a centrally located stair, now demolished, that led to the second floor and the high-ceilinged main reading room. The building was renovated in 1997 for seismic and accessibility upgrades which resulted in architectural impacts including the loss of the historic entry and monumental stairway. Mission Library received landmark status in 2002.

Public Works Bureau of Architecture (BOA) began working with the San Francisco Public Library (SFPL) on the design for Mission Branch Library Renovation in 2018. Through extensive programming efforts with the Library and the Mission community we established the following design goals:

- Provide a 100-person Community Room (there is currently no community room)
- Provide a dedicated Teen Room
- Update the adjacent landscape with secure courtyard adjacent to the Community Room
- Restore the main entry to the original location on the primary facade
- Replace the lost historic main staircase
- Replace obsolete building systems
- Provide sustainability and resiliency upgrades such as rooftop solar panels, battery storage system, air conditioning and enhanced air filtration.
- Provide additional rest rooms

Mission Branch Library Renovation – Approval of Contract Award Public Works Commission Meeting: 12/2/2022

Demolition: Demolition of non-historic construction and sitework will occur as required for the new project. The existing historic west façade will be selectively demolished as required for the new addition. Excavation will be as required for the new basement and foundations.

Restoration: Existing exterior historic walls and windows will be cleaned and repaired including damage to exterior terra cotta tile. The historic reading room will be repaired to original and repainted with a new monumental stair built in the location of the original 1916 stair.

New Construction: The building will be fully renovated with new air conditioning systems, lighting, security systems, fire sprinklers, fire alarm, audiovisual systems, interior finishes, casework, rest rooms, elevator, stairs, and clay tile roof.

Landscape: Existing street trees will be maintained, and adjacent landscape updated with new sidewalk, planters, pedestrian light poles, and a fenced courtyard adjacent to the Community Room

Building Addition: A new two-story addition will be built on the west side adjacent to Orange Alley and will be two stories above grade with a basement. The two stories above grade will house public library functions while the basement will house service spaces and storage.

Electrical Infrastructure: New electrical primary power service will be provided and is being designed in collaboration with the San Francisco Public Utilities Commission and PG&E.

Public Art: The San Francisco Arts Commission commissioned public art through a competitive and community driven process. The selected artist, Juana Alicia, is well known in the Mission community. The art piece is back-lit stained glass and located in the historic reading room.

Community engagement: There was extensive community engagement throughout the design process through in-person and virtual meetings. There are regular project presentations to the San Francisco Public Library Commission which is a public forum. SFPL also maintains a website with project updates. Community engagement to date:

Solicitation Process: Due to the complex and historic nature of the project, the project was bid utilizing the Best Value delivery method in which contractor selection is based on bidder qualifications as well as bid pricing. The bidder qualifications were scored by a three-person panel. At conclusion of qualifications scoring, the bids were tabulated by dividing the bid price by the proposal scores. The entity with the lowest tabulated score is the apparent low bidder and is evaluated for award.

The Department advertised the project on June 7, 2022, and received two responsive bids on August 17, 2022. Bids were evaluated using the Best Value process and the low score was S.J. Amoroso Construction Co., LLC. Staff evaluated the low bid proposal from S.J. Amoroso Construction Co., LLC and it was determined:

- 1. The bid was deemed responsive by Public Works Contract Administration staff
- 2. The bidder was deemed responsible by Public Works Project Manager
- 3. The bid received Contract Monitoring Division's award recommendation

WHEREAS, CMD established a Local Business Enterprise (LBE) subcontracting participation requirement of 20% for this contract, and the contractor committed to LBE participation of 20.35% in its bid submittal; now, therefore, be it

RESOLVED, That this Commission hereby awards Public Works Construction Contract, Mission Branch Library Renovation in the amount of \$23,020,000 for 730 consecutive calendar days to S.J. Amoroso Construction Co., LLC, to perform the complete renovation and expansion of the Mission Branch Library.


