Director's Recommendation: Approve an increase of 253 calendar days to the contract duration for the Various Locations No. 49 Infrastructure Improvements contract with R&S Construction Management Inc; and authorize the Director of Public Works to approve future modifications to the contract for a total contract duration of 468 calendar days.

Contract Background: The Public Works Various Locations No.49 infrastructure improvements contract is one of several paving contracts that contributes to the overall Public Works Street Resurfacing Program goal of maintaining or increasing the overall average condition of San Francisco streets maintained by San Francisco Public Works. San Francisco Public Works currently maintains approximately 12,900 street segments. The infrastructure work performed in this project improved the paving conditions of various streets and installed compliant curb ramps.

The Paving work performed under this contract were located at the following locations:

- 1. Magellan Ave from 12th Ave to Cortes Ave
- 2. Magellan Ave from Cortes Ave to Montalvo
- 3. Magellan Ave from Montalvo to Dorantes Ave
- 4. Magellan Ave from Dorantes Ave to Pacheco St
- 5. Magellan Ave from Pacheco St to Sola Ave
- 6. Magellan Ave from Sola Ave to Plaza Ave
- 7. Pacheco St from Magellan to Marcela Ave
- 8. Pacheco St from Marcela Ave to Castenada Ave
- 9. Pacheco St from Castenada Ave to Lopez Ave
- 10. Pacheco St from Lopez Ave to Alton Ave/8th Ave
- 11. 9th Ave from Mendosa Ave to Sotelo Ave
- 12. 9th Ave from Sotelo Ave to Alton Ave
- 13. 9th Ave from Alton Ave to Pacheco Ave
- 14. 9th Ave from Pacheco Ave to Ortega St
- 15. Pacheco St from 10th Ave to 9th Ave

Various Locations No.49 Infrastructure Improvements - Contract Modification Public Works Commission Meeting: July 21, 2023

On July 23, 2021, Public Works awarded R&S Construction Management Inc (Contractor) a construction contract for this work in the amount of \$1,392,387 with a contract duration of 195 calendar days.

Explanation of Requested Contract Duration: The infrastructure improvement work described above was completed except for a portion of the work on Magellan Avenue. This contract duration increase is necessitated by paving delay on Magellan Avenue caused by a last-minute request from PG&E to delay paving on Magellan Avenue from 12th Avenue to Castenada Avenue to enable PG&Eto construct a new gas main pipeline in the roadway along Magellan Avenue. In addition, following the PG&E work, the Bureau of Urban Forestry (BUF) worked on sidewalk replacement to address sidewalk damage on Magellan Avenue at Pacheco Street resulting from tree roots. When all work was completed by PG&E and BUF, the weather was not suitable to complete paving in late December 2022 and January 2023, due to unprecedent rains and low temperature during that timeframe.

WHEREAS, unprecedented rains and low temperature during the months of December 2022 and January 2023 also contributed to the unforeseen delays; now, therefore, be it


