**Director's Recommendation**: Award As-Needed Specification Writing Services No. 4 Contracts in the amount of \$800,000 each for 1,825 calendar days to Emily Borland Specifications, Inc., and Dabri, Inc. for specification writing services.

**Contract Background**: The work to be done under this contract consists of specification writing services. The consultants would provide specialized services in specifications writing and hardware design to support Public Works design staff on an as-needed basis. The consultants provide expert advice and services to ensure that the most up to date products are utilized in the specifications. The consultants may be required to provide the requested services for an entire project or for a portion of a project or for any project phase. The consultants have provided these types of services for the City in the past.

**Solicitation Process**: On September 20, 2023, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Specification Writing Services No. 4. Public Works sought to award four contracts with an anticipated not-to-exceed contract amount of \$800,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) waived the Local Business Enterprise (LBE) subcontracting requirement for this contract.

On November 8, 2023, Public Works received two proposals. City staff reviewed all proposals and determined that two proposals were responsive and responsible.

The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter.

Optional oral interviews were not conducted.

Proposers Emily Borland Specifications, Inc. and Dabri, Inc. ranked in the top two in the RFQ As-Needed Specification Writing Services No. 4.

RESOLVED, That this Commission hereby awards Public Works professional Services Contract, As-Needed Specification Writing Services No. 4, in the amount of \$800,000, with a contract duration of 1,825 calendar days to Emily Borland Specifications, Inc.
