**Subject**: As-Needed Waterproofing Consultation Services No. 4

Five Contract Awards

**Director's Recommendation**: Award Professional Services Contract As-Needed Waterproofing Consultation Services No. 4 in the amount of \$700,000 each for a duration of 1,825 calendar days each to the following five contractors for waterproofing consultation services: Interactive Resources, Inc., Walker Consultants, Inc., McGinnis Chen Associates, Inc., Aquatech Consultancy, Inc., and Allana Buick & Bers, Inc.

Contract Background: The work to be done under these contracts consists of waterproofing consultation services. The Consultant performs waterproofing consultation services such as, assessment of existing buildings for moisture or water intrusion, preparing plans and specifications for waterproofing details, preparing cost estimates, field inspection, water testing, warranty claim assistance, writing reports, and other related work. Potential projects may include various building facilities such as library buildings, fire stations, police stations, health service centers, hospital buildings, recreation centers, and other City-owned facilities. This type of consultant services has been provided in the past.

**Solicitation Process**: On March 15, 2023, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Waterproofing Consultation Services No. 4. Initially, Public Works sought to award up to five contracts with an anticipated not-to-exceed contract amount of \$700,000 per contract with a duration of 1,825 calendar days per contract. The Contract Monitoring Division (CMD) waived the Local Business Enterprise (LBE) subcontracting requirement for this agreement.

On May 10, 2023, Public Works received five proposals. City staff reviewed all five proposals and determined that all five proposals were responsive and responsible.

These proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter. The proposers were ranked int eh following order from highest score to the lowest score: Interactive Resources, Inc., Walker Consultants, Inc., McGinnis Chen Associates, Inc., Aquatech Consultancy, Inc., and Allana Buick & Bers, Inc.

Optional oral interviews were not conducted.

Consistent with the language in the RFQ, Public Works decided to award five contracts to the five highly qualified proposers because Public Works anticipates high demand for waterproofing consultation work in the near future.
