Two Contract Awards

**Director's Recommendation**: Award Professional Services Contract, As-Needed Environmental Planning Services 2024 in the amount of \$1,000,000 each for 1,825 calendar days to the following two contractors (each a "Consultant"): Panorama Environmental, Inc., and TRC Solutions, Inc. for environmental planning services.

Contract Background: The work to be done under this contract consists of environmental planning services. The Consultant performs environmental planning services, such as performing studies and investigations, preparing plans and specifications, preparing cost estimates, writing reports, and performing field inspections for various types of regulatory, environmental, and health and safety issues. Scope of work includes but is not limited to: 1) project planning services, 2) planning-related reports and studies, 3) environmental compliance monitoring and other related professional services. The consultant may provide the requested services for an entire project, a portion of a project, or any project phase. Consultants have provided this type of services for the City in the past.

**Solicitation Process**: On September 18, 2024, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Environmental Planning Services 2024. Public Works sought to award 5 contracts with an anticipated not-to-exceed contract amount of \$1,000,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) established a 25% Local Business Enterprise (LBE) subcontracting requirement for this contract.

On October 30, 2024, Public Works received two proposals. City staff reviewed both proposals and determined that both proposals were responsive and responsible.

The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter.

Optional oral interviews were not conducted.

The top 2 RFQ proposers for this contract were: Panorama Environmental, Inc. and TRC Solutions, Inc.
