Stantec Consulting Services, Inc., GHD Inc., and LEE & RO, Inc.

Director's Recommendation: Award Professional Services Contract, As-Needed Mechanical Engineering Services No. 3 in the amount of \$1,500,000 each for 1,825 calendar days each to Stantec Consulting Services, Inc., GHD Inc., and LEE & RO, Inc. for mechanical engineering services.

Contract Background: The work to be done under this contract consists of mechanical engineering services. Each consultant will be required to support the efforts of City staff in preparing plans, specifications, and cost estimates; perform field investigations and constructability analysis; write reports on condition assessments; and provide drafting and project scheduling services, value engineering and peer review consultation, Quality Assurance/Quality Control (QA/QC) review, and recommendations for various types of work. The mechanical engineering tasks may include planning, design, and construction of sewage treatment plants, pump stations, water treatment plants, compressed natural gas (CNG) filling systems, and related facilities; heating, ventilation, and air conditioning (HVAC) systems; plumbing systems, emergency generators systems, auxiliary water supply systems (AWSS), surge analysis for pumping stations, materials testing, and other related mechanical engineering services. Consultants have provided Public Works with these services in the past.

Solicitation Process: On August 2, 2023, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Mechanical Engineering Services No. 3. Public Works sought to award 3 contracts with an anticipated not-to-exceed contract amount of \$1,500,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) established a 20% Local Business Enterprise (LBE) subcontracting requirement for this contract.

On September 13, 2023, Public Works received three proposals. City staff reviewed all proposals and determined that all three proposals were responsive and responsible.

The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter.

Optional oral interviews were not conducted.

Proposers Stantec Consulting Services, Inc., GHD Inc., and LEE & RO, Inc. ranked in the top three in the RFQ As-Needed Mechanical Engineering Services No. 3.

WHEREAS, Public Works received three proposals in response to the RFQ As-Needed Mechanical Engineering Services No. 3 on September 13, 2023; and
WHEREAS, the City found a total of three proposals responsive and responsible; and
WHEREAS, All three responsive and responsible proposals were evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter of the RFQ; and
WHEREAS, Optional oral interviews were not conducted; and
WHEREAS, Proposer LEE & RO, Inc. ranked third in the RFQ As-Needed Mechanical Engineering Services No. 3; and now, therefore, be it
RESOLVED, That this Commission hereby awards Public Works professional Services Contract, As-Needed Mechanical Engineering Services No. 3, in the amount of \$1,500,000, with a contract duration of 1,825 calendar days to LEE & RO, Inc.
