**Subject:** As-Needed Architectural Design Services No. 5 (Micro-LBE Set-Aside Program) - Four Contract Awards

**Director's Recommendation:** Award the As-Needed Architectural Design Services No. 5 (Micro-LBE Set-Aside Program) in the amount of \$1,800,000 each for 1,825 calendar days to Mar Jang Design, Office of Charles F. Bloszies, LTD, Jayson Architecture, and HB Associates and Architects, Inc. for architectural design services.

**Contract Background:** The work to be done under this contract consists of architectural design services. The Consultant performs professional architectural and engineering planning and design services for public building projects, including but not limited to master plans, environmental reviews, programming and planning studies, assessments of existing facilities, green building evaluations, utility studies, design drawings, specifications, cost estimates, project schedules, adaptive re-use of existing facilities, modifications to life safety systems and other infrastructure, and new facilities. Projects may include office building interiors, pump stations, recreation centers, clubhouses and pools, fire stations, police stations, branch libraries, transportation facilities, acute care hospital interiors, clinics, cultural centers, homeless shelters, correctional facilities, and other City-owned facilities. Consultant may be required to provide the requested services for an entire project or for a portion of a project or for any project phase. Consultants have provided this type of services for the City in the past.

**Solicitation Process:** On November 8, 2023, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Architectural Design Services No. 5 (Micro-LBE Set-Aside Program). Public Works sought to award four contracts with an anticipated not-to-exceed contract amount of \$1,800,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) waived the Local Business Enterprise (LBE) subcontracting requirement for this contract.

On January 22, 2024, Public Works received seven proposals. City staff reviewed all proposals and determined that six proposals were responsive and responsible.

The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter.

Optional oral interviews were not conducted.

Proposers Kuth Ranieri Architects LLP, and LDA Architects Inc also submitted proposals responding to RFQ 8860 As-Needed Architectural Design Services No. 4, and scored well on both RFQ’s 8860 (LDA JV’ed with KMD, and KR JV’ed with RDC) and 8861. Per the RFQ’s, only one contract can be awarded to a consultant for As-Needed Architectural Design Services. Both JV’s selected to pursue RFQ 8860 As-Needed Architectural Design Services No. 4.

Proposers Mar Jang Design, Office of Charles F. Bloszies, LTD, Jayson Architecture, and HB Associates and Architects, Inc. ranked in the top four in the RFQ As-Needed Architectural Design Services No. 5 (Micro-LBE Set-Aside Program).

WHEREAS, Proposers LDA Architects Inc and Kuth Ranieri Architects selected to pursue RFQ As-Needed Architectural Design Services No. 4; and

WHEREAS, Proposer Mar Jang Design ranked first in the RFQ As-Needed Architectural Design Services No. 5 (Micro-LBE Set-Aside Program); and now, therefore, be it




