Subject:	As-Needed Project Controls and Construction Management Services No. 4 (Micro-LBE Set-Aside Program) - 3 Contract Awards

**Director's Recommendation**: Award Professional Services Contract, As-Needed Project Controls and Construction Management Services No. 4 (Micro-LBE Set-Aside Program) each in the amount of \$1,500,000 with a duration of 1,825 calendar days, to the following three (3) contractors (each a "Consultant"): Construction Management West, Inc. (CM West), Joe Hill Consulting Engineers (JHCE), and Design & Construction Management Services, Inc. (DCMS) for project controls and construction management services.

**Contract Background**: The work to be done under each contract consists of project controls and construction management services. Services to be performed include but are not limited to, project scheduling, cost estimating, constructability review, construction inspection, training, public and community relations, public affairs, dispute resolution, report investigations, technical advice, and other related services. Consultants may provide the requested services for an entire project, a portion of a project, or any project phase. Consultants may provide requested services for an entire project, a portion of a project, or any project phase. Consultants have provided these types of services for the City in the past.

**Solicitation Process**: On July 9, 2024, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Project Controls and Construction Management Services No. 4 (Micro-LBE Set-Aside Program). Public Works sought to award 3 contracts with an anticipated not-to-exceed contract amount of \$1,500,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) waived the Local Business Enterprise (LBE) subcontracting requirement for this contract.

On August 19, 2024, Public Works received eight proposals, all of which were reviewed and deemed responsive and responsible by City staff. These proposals were evaluated and scored by a panel of subject matter experts. Optional oral interviews were not conducted.

Proposer A G S, Inc. (AGS) submitted a proposal responding to RFQ 9529 As-Needed Project Controls and Construction Management Services No. 3, and scored well on both RFQs 9529 and 9530. Per the RFQs, each consultant for As-Needed Project Controls and Construction Management Services may only be awarded one of the contracts. AGS elected to pursue RFQ 9529 As-Needed Project Controls and Construction Management Services No. 3. The top 3 RFQ proposers for this contract, which is associated with RFQ 9530, were: Construction Management West, Inc., Joe Hill Consulting Engineers, and Design & Construction Management Services, Inc.**Contract Details**:

WHEREAS, On July 9, 2024, San Francisco Public Works (Public Works) advertised the Request for Qualifications (RFQ) for As-Needed Project Controls and Construction Management Services No. 4 (Micro-LBE Set-Aside Program) to establish a pool of qualified consultants; and

WHEREAS, The RFQ specified a not-to-exceed contract amount of up to \$1,500,000 and a duration of 1,825 calendar days for these services; and

WHEREAS, Public Works intended to award contracts to three pre-qualified prime consultants or joint ventures through the RFQ; and

WHEREAS, The Contract Monitoring Division (CMD) waived the Local Business Enterprise (LBE) subcontracting requirement for this contract; and

WHEREAS, On August 19, 2024, Public Works received eight proposals in response to the RFQ all of which were deemed responsive and responsible, after being evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter of the RFQ, and optional oral interviews were not conducted; and

WHEREAS, Proposer A G S, Inc. (AGS) ranked first in the evaluation for RFQ As-Needed Project Controls and Construction Management Services No.4 (Micro-LBE Set-Aside Program) but opted to pursue a contract opportunity under a related RFQ for As-Needed Project Controls and Construction Management Services No. 3; and

WHEREAS, Following AGS' decision to pursue a contract opportunity under As-Needed Project Controls and Construction Management Services No. 3, proposer Joe Hill Consulting Engineers ranked second in the RFQ As-Needed Project Controls and Construction Management Services No. 4 (Micro-LBE Set-Aside Program); now, therefore, be it

RESOLVED, That this Commission hereby awards Public Works Professional Services Contract, As-Needed Project Controls and Construction Management Services No. 4 (Micro-LBE Set-Aside Program), in an amount not to exceed \$1,500,000, with a contract duration of 1,825 calendar days to Joe Hill Consulting Engineers.
