Subject: San Francisco Rent Board Tenant Improvement – Contract Award

Director's Recommendation: Award San Francisco Rent Board Tenant Improvement contract in the amount of \$1,408,768.00 for 229 consecutive calendar days to Chiang C.M. Construction, Inc. to make tenant improvements to enable the relocation of the San Francisco Rent Board to the 7th floor (Suite 700) of 25 Van Ness Avenue.

Contract Background: The San Francisco Rent Board (SFRB) is relocating to the 6th and 7th floors of 25 Van Ness Avenue. This contract is for the 7th floor (Suite 700) work only and the 6th floor is not part of this scope of work. Located in the southwest quadrant, Suite 700 bounds a central glazed atrium and is approximately 6,713 square feet.

Most of the suite's existing construction will remain except for room modifications to the existing waiting room and reception area to increase their size. In addition, the breakroom will be relocated from the northwest quadrant to the southeast quadrant and walls on the north side will be modified to create a larger meeting room and increase acoustic privacy. The new breakroom will receive new countertops, cabinetry and plumbing connections for a sink and a refrigerator.

The existing carpet will be replaced with new carpet tile. An internal stair that connects the 6th and 7th floors will also receive new carpet and wallcovering. New paint will be provided.

No new doors are required for this project as existing doors will be reused. Some existing doors and hardware will be removed from the current locations and reused. Public Works Bureau of Building Repair will rekey the locks as needed.

Light fixtures will be replaced, except for existing pendant lights that surround the atrium. The existing ceiling tile hangers will be reused, and new acoustic ceiling tiles will be installed. New power and data is to be provided. Data cable installation will be provided by the City's Department of Technology.

Existing heat pumps and mechanical ducts will remain. Existing ceiling diffusers will be replaced. New thermostats will be provided.

Accessibility upgrades will be required and include new signage, relocation of toilets, relocation of toilet accessories, and new toilet partitions.

Solicitation Process: The Department advertised the project on March 9, 2023, and received six responsive bids on May 10, 2023. Staff evaluated the low bid proposal from Chiang C.M. Construction, Inc and determined:

1. The bid was deemed responsive by Public Works Contract Administration staff.
2. The bidder was deemed responsible by the Public Works Project Manager.
3. The bid received Contract Monitoring Division’s award recommendation.

Project Manager Recommendation: The project team has concluded its review of the bids submitted for the subject project. We find that Chiang C.M. Construction, Inc., has met the experience requirements, is responsible, and is qualified to perform the work. We recommend Chiang C.M. Construction, Inc. for award of contract.

Contract Background: The San Francisco Rent Board (SFRB) is relocating to the 6th and 7th floors (Suite 700) of 25 Van Ness Avenue. The 6th floor is not part of the scope of work. The approximate square footage of Suite 700 is 6,713 SF. Located in the southwest quadrant, Suite 700 bounds a central glazed atrium.

Most of the suite's existing construction will remain except for room modifications to the existing waiting room and reception area to increase the size; relocation of the breakroom from the northwest quadrant to the southeast quadrant; removal of selective on walls on the north side to create larger meeting rooms; and modifying the walls on the north side to extend to the underside of the deck to increase acoustic privacy. The new breakroom will require new countertops, cabinetry and plumbing connections for a sink and a refrigerator.

The existing broadloom carpet will be removed and replaced with new carpet tile. An internal stair that connects the 6th and 7th floors will also receive new carpet and wallcovering. New paint is required throughout, except areas that are specifically identified to remain as is.

No new doors are to be fabricated or procured for this project. Some existing doors and its hardware are to be removed from the current locations and reused. The City's Bureau of Building Repair will rekey the locks as needed.

Most of the light fixtures will be replaced, except for the existing pendant lights that surround the atrium. The existing ceiling tile hangers will be reused, and only new acoustic ceiling tiles will be installed. New power and conduit for data is to be provided. Pulling the data cables to proper locations will be provided by the City's Department of Technology.

Existing horizontal heat pumps and mechanical ducts to remain. Existing ceiling diffusers to be replaced. New thermostats to be provided.

Accessibility upgrades will be required and include new signage, relocation of toilets, relocation of toilet accessories, and new toilet partitions.
