Subject:	As-Needed Architectural Services for Health Facilities No. 3 - Award Professional Services Contract

**Director's Recommendation**: Award Professional Services Contract, As-Needed Architectural Services for Health Facilities No. 3 (Re-Advertisement) in the amount of \$2,000,000 for 1,825 calendar days to Perkins Eastman Architects for architectural design services for health facilities.

**Contract Background**: The work to be done under this contract consists of professional architectural design services for health facilities. The consultant will work with professionals from multiple disciplines to design and build health facilities, under the purview of the Department of Health Care Access and Information (HCAI), and/or the San Francisco Department of Building Inspection. These professional services shall be provided either by the direct assignment of the Consultants' personnel or through sub-consultants listed as a part of the firms' team. Requested services may involve an entire project or for a portion of a project or for any project phase. This type of consultant services has been provided in the past.

**Solicitation Process**: On June 29, 2022, San Francisco Public Works (Public Works) readvertised the Request for Qualifications (RFQ) for As-Needed Architectural Services for Health Facilities No. 3 contract to re-open the pool of qualified consultants. Public Works sought to award one contract with an anticipated not-to-exceed contract amount of \$2,000,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) established a Local Business Enterprise (LBE) subcontracting requirement of 20% for this agreement.

On August 10, 2022, Public Works received two proposals. City staff reviewed both proposals and determined that both were responsive and responsible. The proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter. Optional Oral Interviews were cancelled. Proposer Perkins Eastman Architects achieved the highest final score.
