Director's Recommendation: Award three Professional Services Contracts, As-Needed Audio / Visual, Telecom, IT, Security, and Acoustical Design and Consultation Services No. 1, each in the amount of \$500,000 for 1,825 calendar days, to Shen Milsom and Wilke LLC, Veneklasen Associates, Inc., and Arup US, Inc. for audio / visual, telecom, IT, security, and acoustical design and consultation services.

Contract Background: The work to be done under these contracts consists of audio / visual, telecom, IT, security, and acoustical design and consultation services. The Consultant will provide highly specialized services in audio-visual, telecom, IT, security, and acoustical design and consultation to support Public Works design staff on an as-needed basis. Work may involve measuring noise and vibration levels, calculating and designing engineering noise controls, engineering architectural acoustics to achieve good speech intelligibility and or precise and accurate sound, preparing environmental noise report, and other related services. Projects may include various building facilities, such as library buildings, fire stations, police stations, health service centers, hospital buildings, recreation centers, and other City-owned facilities. The Consultant may be required to provide the requested services for an entire project or for a portion of a project or for any project phase. This type of consultant services has been provided in the past.

Solicitation Process: On February 1, 2023, San Francisco Public Works advertised the Request for Qualifications (RFQ) for As-Needed Audio / Visual, Telecom, IT, Security, and Acoustical Design and Consultation Services No. 1. Public Works sought to award four contracts with an anticipated not-to-exceed contract amount of \$500,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) established 20% Local Business Enterprise (LBE) subcontracting requirement for this agreement.

On March 15, 2023, Public Works received four proposals. City staff reviewed all proposals and determined that three proposals were responsive and responsible.

The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter.

Optional oral interviews were cancelled.

Proposer Shen Milsom and Wilke LLC achieved the first highest final score.
