Subject: Tree Watering Workforce Development Grant Award - San Francisco

Conservation Corps

Director's Recommendation: Award the Tree Watering Workforce Development Grant ("Tree Watering WFD RFP") to the San Francisco Conservation Corps in a not to exceed amount of \$2,226,000 for a 12-month term to operate and manage a workforce development program to support participants in developing careers beyond the program by connecting them to employment and apprenticeship opportunities at Public Works, other public agencies, non-profit partners, and private companies through experience in tree watering services.

Grant Background:

San Francisco Public Works' Bureau of Urban Forestry (BUF) is committed to preserving and growing the City's tree canopy. The City of San Francisco's Urban Forest Plan set a goal of increasing the street tree population to 155,000 street trees over 20 years. The watering of newly planted street trees provides a valuable workforce development training opportunity. With low barriers to entry, this work can offer temporary employment and career development opportunities leading to stable jobs in urban forestry, landscape maintenance and related fields. The Tree Watering Grant will provide funding to a non-profit organization that can successfully carry out the goals of increasing the street tree population while simultaneously developing career pathways for those facing barriers to employment.

The Tree Watering Workforce Development Grant scope of work includes:

Employment Readiness and Job Support Services

- Provide urban forestry job training and skills development.
- Conduct workshops and training related to resume writing, job search skills, interview skills, job applications, and using online services to find and apply for jobs, as well as conflict management and de-escalation techniques.
- Connect participants to employment and apprenticeship opportunities at Public Works, other public agencies, non-profit partners, and private companies.

Tree Watering Services

- Water a minimum of 2,000 street trees weekly to ensure establishment after planting.
- Perform watering from a water tank or truck with each tree receiving 25-30 gallons of water per week (20 gallons of water in the Treegator bag and 5-10 gallons on the rootball).

- Replace damaged or missing watering bags and missing tree stakes, cross braces and ties.
- Perform weeding and litter picking of tree basins.

Solicitation Process: Public works issued Sourcing ID 0000006777 – Tree Watering WFD RFP on May 9, 2023, with a July 5, 2023 deadline to submit proposals. On July 5, 2023, Public Works received two proposals for the Tree Watering WFD RFP with an intent to award one grant. City staff reviewed all proposals and determined that both were responsive and responsible. The responsive and responsible proposals were then evaluated and scored by a panel comprised of subject matter experts from San Francisco Public Works and UCSF. Proposer San Francisco Conservation Corps was the highest ranked proposal for the Tree Watering WFD RFP based on the panelists scores.

RESOLUTION NO
WHEREAS, the Tree Watering Workforce Development grant will provide valuable job training and job placement support to San Francisco residents from disadvantaged communities through a workforce development program focused on the weekly watering of a minimum 2,000 street trees. The workforce development program will include job readiness and soft skills to assist participants in their transition to the workforce and develop careers beyond the program by connecting them to employment and apprenticeship opportunities at Public Works, other public agencies, non-profit partners, and private companies.
WHEREAS, On May 9, 2023, San Francisco Public Works (Public Works) advertised the Bureau of Urban Forestry Workforce Development Request for Proposal – Tree Watering Workforce Development Program (the "Tree Watering WFD RFP"); and
WHEREAS, The not-to-exceed grant amount is anticipated to be up to \$2,226,000, and the agreement will have an initial duration of 12 months for these services; and
WHEREAS, Public Works intended to award one grant through the Tree Watering WFD RFP; and
WHEREAS, Public Works received two proposals in response to the Tree Watering WFD RFP on July 5, 2023; and
WHEREAS, City staff found both proposals responsible and responsive to the Tree Watering WFD RFP; and
WHEREAS, Both responsive and responsible proposals were evaluated and scored by a panel comprised of subject matter experts of the RFP; and
WHEREAS, San Francisco Conservation Corps ranked first in the Tree Watering WFD RFP; now, therefore, be it
RESOLVED, That this Commission hereby awards Public Works Grant Tree Watering WFD RFP, in the amount of \$2,226,000, with a contract duration of 12 months to San Francisco Conservation Corps.

Grant Overview and Scope of Work

Background: The grant will support a non-profit organization in operating and managing a tree watering workforce development program and support participants in developing careers beyond the program by connecting them to employment and apprenticeship opportunities at Public Works, other public agencies, non-profit partners, and private companies.

Benefits: The grant will provide paid training and employment to residents from disadvantaged communities in performing tree watering services.

Details: The grantee will water a minimum of 2,000 street trees throughout San Francisco as well as provide urban forestry job training, skills development and job placement support.

Director's Recommendation: Award the Tree Watering Workforce Development Contract to San Francisco Conservation Corps in the amount of \$2,226,000.



Grant Components
