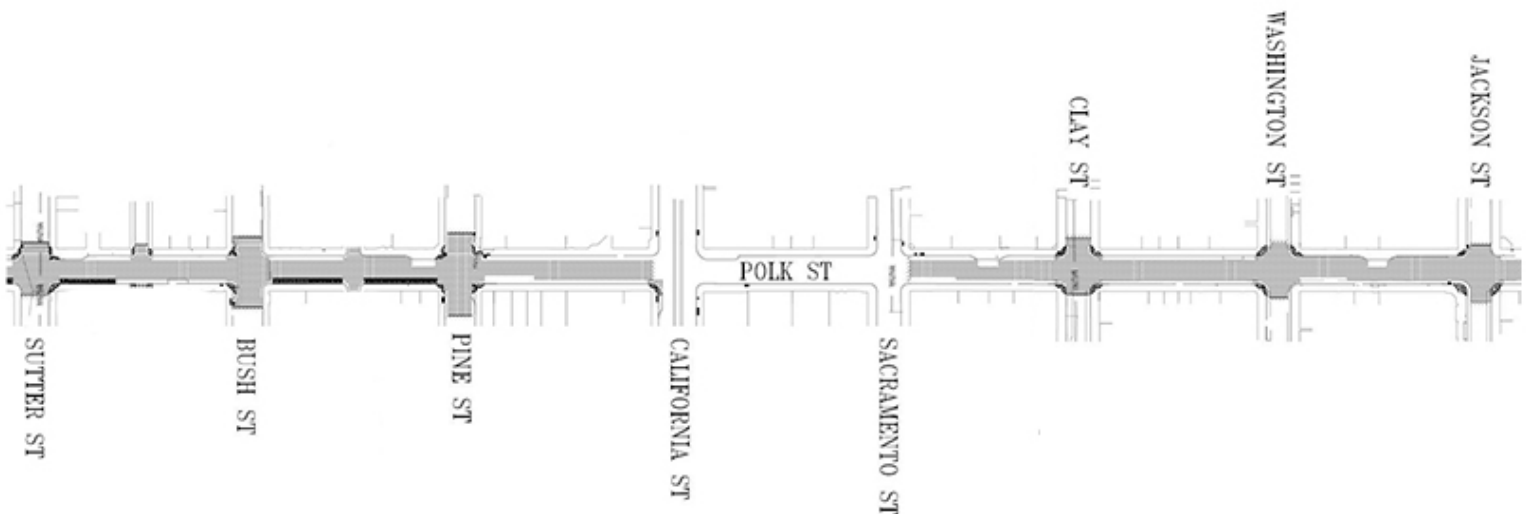

UPDATE - Polk Streetscape Project Paving Notice

Polk Street, Jackson to Sacramento, California to Sutter and the intersection of Polk and Beach

Dear Polk Street Community Member,

San Francisco Public Works has completed major construction activity within segments 3 and 2 of the Polk Streetscape Project (Contract No. 2126J) and will soon begin final roadway paving of **Polk Street, from Jackson to Sacramento, from California to Sutter and the intersection of Polk and Beach**. Crews anticipate paving activity to begin on **Monday, July 30, 2018***.

Paving will be performed in phases of three block segments and is anticipated to take approximately two days* per phase.

Day 1 (07/30/18*) - Polk Street, from Jackson to Sacramento: Crews will grind the roadway to prepare it for final paving. Access to enter and exit driveways will be maintained at all times, however minor delays may be possible. Once grinding work is complete, you will be able to drive on the roadway. Please use caution when entering and exiting the roadway and drive carefully.

Day 2 (07/31/18*) Polk Street, from Jackson to Sacramento: Paving of the roadway and application of temporary traffic striping.

Day 3 (08/01/18*) - Polk Street, from California to Sutter: Crews will grind the roadway to prepare it for final paving. Access to enter and exit driveways will be maintained at all times, however minor delays may be possible.

Day 4 (08/02/18*) - Polk Street, from California to Sutter: Paving of the roadway and application of temporary traffic striping. Crews may also perform grinding activity at the intersection of **Polk and Beach**.

Day 5 (08/03/18*) – Crews will pave the intersection of Polk and Beach.

Once all paving work is complete, San Francisco Public Works will inspect the newly paved roadway. Once approved, final traffic striping, including color curb, crosswalk and bike lane markings, will be applied by SFMTA. Please note, it may be several weeks after paving activity before final traffic striping is applied.

Impacts and Restrictions

Street parking is prohibited in the work area during posted work hours. Street parking will be re-opened to the public each day once crews have completed grinding or paving activity in that area.

Access to private or commercial buildings/garages and pedestrian pathways will be maintained at all times, however delays may be possible. Please follow instructions from crewmembers on site if you need to enter or exit your property during posted work hours.

“No Parking/Tow Away” signs will be posted 72 hours in advance of work starting with project work hours and parking restrictions. Please observe posted no parking hours and traffic signage and allow extra travel time in case of traffic delays during construction. **Vehicles parked in the construction zone during posted work hours will be towed at the vehicle owner’s expense.**

General Work Hours**

Monday - Friday: 8 AM – 5 PM

*Weekend/evening work may be possible, but has not been scheduled at this time. **Please Note: Crews may begin setup work prior to 8 AM, as early as 7AM, if needed.***

We thank you in advance for your patience during construction and as we work to complete these much needed infrastructure improvements on Polk Street.
