**Director's Recommendation:** Award Professional Services Contract, As-Needed Surveying Services No. 6 in the amount of \$2,000,000 each for 1,825 calendar days each to Towill, Inc., Chaudhary & Associates, B K F Engineers, and F3 & Associates, Inc. for surveying services. Award Professional Services Contract, As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program) in the amount of \$2,000,000 for 1,825 calendar days to Mike O'Dell Surveys, Inc. for surveying services.

**Contract Background:** The work to be done under these contracts consists of surveying services. Public Works seeks to hire consultants to perform highly specialized professional land surveying work, such as topographic, boundary, and construction surveys; photogrammetric work; laser 3D scanner field and office assistance and training; AutoCAD Civil 3D drafting; and help with special projects (e.g., monumentation, GIS mapping, GPS network, etc.). The consultants hired may be required to provide the requested services for an entire project or for a portion of a project or for any project phase. This type of consultant services has been provided in the past.

**Solicitation Process:** On July 20, 2023, Public Works advertised the Request for Qualifications (RFQ)'s for As-Needed Surveying Services No. 6 and As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program). Public Works sought to award 9 contracts with an anticipated not-to-exceed contract amount of \$2,000,000 each with a contract duration of 1,825 calendar days per contract. The Contract Monitoring Division (CMD) established 20% Local Business Enterprise (LBE) subcontracting requirement for RFQ As-Needed Surveying Services No. 6. CMD did not have LBE subcontracting requirements for RFQ As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program). RFQ As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program) is open only to small, local firms that have City and County of San Francisco CMD Micro-LBE certification in Surveying certification category.

On September 20, 2023, Public Works received four proposals for RFQ As-Needed Surveying Services No. 6. On September 22, 2023, Public Works received one proposal for RFQ As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program). City staff reviewed all five proposals and determined that five proposals were responsive and responsible.

The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter.

Optional oral interviews were not conducted.

Proposers Towill, Inc., Chaudhary & Associates, B K F Engineers, and F3 & Associates, Inc. ranked in the top four for RFQ As-Needed Surveying Services No. 6. Proposer Mike O’Dell Surveys, Inc. ranked first for RFQ As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program).

WHEREAS, On July 20, 2023, Public Works advertised the Request for Qualifications (RFQ) for As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program) to establish a pool of qualified micro-LBE consultants; and

WHEREAS, The not-to-exceed contract amount is anticipated to be up to \$2,000,000 per contract; and the agreement will have a duration of 1,825 calendar days for each contract, and

WHEREAS, Public Works intended to award contracts to a total of nine pre-qualified prime consultants or joint ventures through the RFQ for As-Needed Surveying Services No. 6 and the RFQ for As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program); and

WHEREAS, Contract Monitoring Division (CMD) established a 20% Local Business Enterprise (LBE) subcontracting requirement for RFQ As-Needed Surveying Services No. 6; and

WHEREAS, Contract Monitoring Division (CMD) did not have Local Business Enterprise (LBE) subcontracting requirement for RFQ As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program); and

WHEREAS, Public Works received four proposals in response to the RFQ As-Needed Surveying Services No. 6 on September 20, 2023; and

WHEREAS, Public Works received one proposal in response to the RFQ As-Needed Surveying Services No. 7 (Micro-LBE Set-Aside Program) on September 22, 2023; and

WHEREAS, The City found a total of five proposals responsive and responsible; and

WHEREAS, All five responsive and responsible proposals were evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter of these RFQ's; and

WHEREAS, Optional oral interviews were not conducted; and

WHEREAS, Proposer Chaudhary & Associates, Inc. ranked second in the RFQ As-Needed Surveying Services No. 6; now, therefore, be it

RESOLVED, That this Commission hereby awards Public Works Professional Services Contract, As-Needed Surveying Services No. 6, in the amount not to exceed \$2,000,000, with a contract duration of 1,825 calendar days to Chaudhary & Associates, Inc.
