Director's Recommendation: Award Professional Services Contract, As-Needed Electrical Engineering Services No. 4 in the amount of \$1,200,000 each for 1,825 calendar days to LEE & RO, Inc., GHD Inc., and HRA Consulting Engineers for electrical engineering services. Award Professional Services Contract, As-Needed Electrical Engineering Services No. 5 (Micro-LBE Set-Aside Program) in the amount of \$1,200,000 each for 1,825 calendar days to AAES, Inc. for electrical engineering services.

Contract Background: The work to be done under this contract consists of electrical engineering services. The Consultant is required to support the efforts of City staff in preparing plans, specifications, and cost estimates; perform field investigations and constructability analysis; write reports on condition assessments; provide drafting and project scheduling services, value engineering and peer review consultation, Quality Assurance/Quality Control (QA/QC) review, and recommendations for various types of work. The electrical engineering tasks may include electrical power distribution and lighting system design for both commercial and industrial type facilities that may involve low and medium voltage systems; design involving water and wastewater plant process improvements, power system coordination/reliability studies, process instrumentation and control system (I&C) design, and other electrical engineering consultations. This type of consultant services has been provided in the past.

Solicitation Process: On April 27, 2023, San Francisco Public Works advertised the Request for Qualifications (RFQ)'s for As-Needed Electrical Engineering Services No. 4, and As-Needed Electrical Engineering Services No. 5 (Micro-LBE Set-Aside Program). Public Works sought to award a total of five contracts with an anticipated not-to-exceed contract amount of \$1,200,000 with a contract duration of 1,825 calendar days. The Contract Monitoring Division (CMD) established 20% Local Business Enterprise (LBE) subcontracting requirement for RFQ As-Needed Electrical Engineering Services No. 4. CMD did not have LBE subcontracting requirement for RFQ As-Needed Electrical Services No. 5 (Micro-LBE Set-Aside Program). The RFQ As-Needed Electrical Engineering Services No. 5 (Micro-LBE Set-Aside Program) is open only to small, local firms that have City and County of San Francisco CMD Micro-LBE certification in Electrical Engineering certification category.

As-Needed Electrical Engineering Services No. 4. and As-Needed Electrical Engineering Services No. 5 (Micro-LBE Set-Aside Program – Four Contract Awards Public Works Commission Meeting: October 20, 2023

On June 16, 2023, Public Works received three proposals for RFQ As-Needed Electrical Engineering Services No. 4. On June 7, 2023, Public Works received one proposal for RFQ As-Needed Electrical Engineering Services No. 5 (Micro-LBE Set-Aside Program). City staff reviewed all four proposals and determined that all four proposals were responsive and responsible.

The responsive and responsible proposals were then evaluated and scored by a panel comprised of individuals knowledgeable on the subject matter.

Optional oral interviews were not conducted.

Proposers LEE & RO, Inc., GHD Inc., and HRA Consulting Engineers ranked in top three in the RFQ As-Needed Electrical Engineering Services No. 4. Proposer AAES, Inc. ranked first in the RFQ As-Needed Electrical Engineering Services No. 5 (Micro-LBE Set-Aside Program).


